Tip of the Week

Periods of Recruiting Activities

Dead Period – A dead period is a period of time when it is not permissible to make in-person recruiting contacts or evaluations on or off the institution's campus or to permit official or unofficial visits by prospective student athletes to the institution's campus. The provision of complimentary admissions to a prospective studentathlete during a dead period is prohibited, except as provided in Bylaw 13.7.2.5 for a prospective studentathlete who visits an institution as part of a group. During a dead period, a coaching staff member may not serve as a speaker at or attend a meeting or banquet at which prospective student-athletes are in attendance except as provided in Bylaw 13.1.8.1 and may not visit a prospective student-athlete's educational institution. It remains permissible, however, for an institutional staff member to write or telephone a prospective student athlete during a dead period.

NCAA News: Andy Baggot: Use of Social Media Presents New NCAA Compliance Challenges

The list of 20 secondary violations submitted by the University of Wisconsin to the NCAA for 2012-13 includes two references to social media.

There was an impermissible text message sent from a member of the swimming staff to a prospective student-athlete, and the identities of three women's basketball recruits were posted on a public Twitter feed used by the coaching staff. Katie Smith, the UW assistant athletic director for compliance, says it's not the first time a social media mechanism led to a self-reported violation on her watch, but it is the first time one was specified in an annual accounting released by the school.

Of all the challenges that come with trying to keep everyone in compliance with NCAA rules at UW Athletics — the NCAA and Big Ten Conference rule books are chock full of ambiguous curiosities — social media might be the biggest because it's such an evolving frontier.

"The rules are constantly trying to keep up with that, and that's complicated," Smith said. "It's difficult to do."
"There's not really a black-and-white rule for every single instance that comes up in social media because it's constantly changing."

Smith said questions about Twitter and Facebook have zoomed down the social media superhighway to Vine and Instagram.

"There's no specific interpretation on it, and it's something that we have to deal with," she said.

The 20 violations, encompassing 11 sports as well as administration, are about average for UW. In an odd way, having a manageable list of secondary violations is viewed as a good thing by the NCAA because it reflects a proactive culture of compliance. It's the schools that have handful — or none at all — that raise investigative eyebrows.

In addition to the list of violations — football, women's basketball, men's and women's hockey, men's rowing, men's and women's soccer, men's track, volleyball and wrestling had at least one each — UW officials issued three letters of admonishment in 2012-13, all obtained through an open records request.

The letters went to volleyball assistant coach Brittany Dildine for providing entertainment and travel expenses to three student-athletes participating in the USA national team tryouts in Colorado; volleyball director of operations Jessica Yanz for publicly commenting on recruits before the rules allow; and former W Club executive director Terry Murawski for interacting with a prospective student-athlete and her parents during an official campus visit.

Smith outlined how difficult it is to wade through the vagaries of social media as they relate coaches, recruits and NCAA rules. She said it's impermissible for staffers to post on a prospect's Facebook wall, but you can reach them via the email function of Facebook.

"You're allowed to use part of it, but not all of it," Smith said.

Meanwhile, a UW coach can follow a prospect on Twitter — regardless of age, even if they're too young to receive correspondence from the school — "which is opposite of what you can do on Facebook," Smith said.

"You still can't post on their Twitter feed, you still can't direct message them if they're not of permissible age, but a coach could follow a freshman on their Twitter page as long as they're not doing anything else."

The social media sword cuts both ways, though. While there are interpretive black holes, Smith can respond quickly to questions by way of texts and can educate via Twitter.

The issues and questions are never-ending.
