Promotion/Endorsement of PSA's Team, Coach or Athletics Facility

Here is a quick refresher on promotion and endorsing prospective student athlete's team, coaches or athletic facilities.

An athletic department staff member shall not promote or endorse a prospective student-athlete's team or coach, or an institutions facility that is primarily used by prospective student-athletes.

If you are unsure whether you are promoting, or endorsing a prospective student-athlete's event, team, coach, or facility please contact the WSU Compliance Office.


