#### Tip of the Week

##### **Permissible Travel Expenses Not Related to Practice or Competition**

An institution, conference or the NCAA may provide actual and necessary expenses to a student-athlete to represent the institution in noncompetitive events (i.e. goodwill tours, media appearances (see Bylaw 12.5.3), student-athlete advisory committee meeting). Further, an institution may provide a reasonable local transportation to student-athlete on an occasional basis.
