Tip of the Week

Countable Coach

An institutional member or any other individual outside the institution (e.g., consultant, professional instructor) with who the institution has made arrangements must count against coaching limits in the applicable sport as soon as the individual participates (in any manner) in any of the following:

- a) Provides technical or tactical instruction related to the sport to a student-athlete at any time;
- b) Makes or assists in making tactical decisions related to the sport during on –court or on-field practice or competition; or
- c) Engages in any off-campus recruiting activities.

Use of Sport Psychologist

A sport psychologist may attend practice sessions without being included in the institution's coaching limitation in a particular sport, provided the institution does not provide any technical or tactical instruction related to the sport or make or assist in making tactical decisions related to the sport during on-court or on-field practice or competition. A sport psychologist may evaluate a student-athlete during a practice session only if the purposes of assisting the student-athlete in off-court or off-field noncoaching activities (e.g., mental imagery) directly related to the sport; however, If a student-athlete is required to meet with the sports psychologist, such a meeting is considered a countable athletically related activity.

An institution may also require a student-athlete to meet with a sports psychologist as permissible out-of-season conditioning activity, provided the time engaged in the sessions are included in the maximum limit of eight hours per week for countable athletically related activities outside the playing season. In bowl subdivision football, the sport psychologist does not have to count as one of the five strength and conditioning coaches permitted to work with the football program in any capacity.
