Tip of the Week

Sports Wagering Activities

The following individuals shall not knowingly participate in sports wagering activities or provide information to individuals involved in or associated with any type of sports wagering activities concerning intercollegiate, amateur or professional athletics competitions:

- (a) Staff members of an institution's athletics department;
- (b) Nonathletics department staff members who have responsibilities within or over the athletics department. (e.g. chancellors or president, faculty athletics representatives, individual to whom athletics reports);
- (c) Staff members of a conference office; and
- (d) Student-athletes.

NCAA Bylaws 10.3

Scope of Application: The prohibition against sports wagering applies to any institutional practice or any competition (intercollegiate, amateur or professional) in a sport in which the Associated conducts championship competition, in bowl subdivision football and in emerging sports for women.
