With March Madness in its second week, please remember that student-athlete, coaches, athletics department staff, non-athletics department staff who have athletic oversight responsibilities and conference staff **MAY NOT**;

- Provide information to people involved in sports wagering
- Participate in sports wagering, including pools, Internet wagering, actions of teams, and fantasy leagues in which an entry fee is required and there is an opportunity to win a prize.

A wager is any agreement in which an individual agrees to give up an item of value (e.g. cash, shirt, dinner) in exchange for the chance to gain another item of value.
