Promotion/Endorsement of PSA's Team, Coach or Athletics Facility

The Compliance Office would like to provide a quick refresher on promoting and endorsing a prospective student athlete's team, coaches or athletic facilities.

An athletic department staff member shall not promote or endorse a prospective student-athlete's team or coach, or an institutions facility that is primarily used by prospective studentathletes.

Photographs of Prospective Student-Athletes in Camp or Clinic Information and Advertisements (I)

A photograph of a prospective student-athlete (or multiple prospective student-athletes) taken during the normal course of camp or clinic activities (e.g., instruction, competition, meals, entertainment) may be used in camp or clinic information and advertisements for future camps or clinics. It is generally not permissible to use a photograph of a prospective student-athlete (or multiple prospective student-athletes) taken in circumstances other than the normal course of camp or clinic activities (e.g., staged or arranged photographs) in camp or clinic information or advertisements. However, once a prospective student-athlete has signed a National Letter of Intent, the institution's written offer of admission and/or financial aid or the institution has received his or her financial deposit in response to the institution's offer of admission a staged or arranged photograph may be used in camp or clinic information and advertisements only in the same manner in which it is permissible to use photographs of student-athletes.

Find a SIX digit number in which the FIRST digit is ONE more than the THIRD, the SECOND digit is ONE less than the FOURTH, the FIFTH digit is ONE less than the THIRD, and the SIXTH digit is ONE more than the FOURTH.
